A MAJOR EMPHASIS IS THE MISSION'S RESIDENTIAL ADDICTION RECOVERY PROGRAMS FOR MEN (120 BEDS), INCLUDING FOOD, SHELTER, CLOTHING, BIBLE STUDY, ADDICTION RECOVERY EDUCATION, JOB TRAINING, COUNSELING AND CARING SUPPORT FOR RECOVERY SUCCESS. THE GOAL IS TO HELP MEET THE PHYSICAL, EMOTIONAL AND SPIRITUAL NEEDS OF PARTICIPANTS SO THEY CAN OVERCOME ADDICTIONS AND PROBLEMS FROM THE INSIDE OUT AND RETURN TO NORMAL SOCIETY FUNCTIONS.
